Description of the Defect : A 14 gauge and a 12 gauge neutral wire in the Electronic Management System were terminated under the same lug in the 120 volt panel neutral bus bar.

FMVSS 1 : NR

Description of the Safety Risk : If both gauge wires are terminated under the same lug, the 14 gauge wire may overheat due to increased AMPs passing through the 12 gauge wire. This may lead to electrical failure, electrical arcing, melting or fire of the electrical wires sheathing potentially increasing the risk of a fire.

Description of the Cause : The process for terminating the 110V AC wire was not consistently followed.

Chronology :

On December 13, 2017 Forest River Corporate Engineering received a letter from the State of Nebraska's Public Service Commission indicating that the State had inspected four Forest River Cherokee vehicles on dealers' lots and found that a 14 gauge and a 12 gauge neutral wire were terminated under the same lug in the 120 volt panel neutral bus bar. The dates of these inspections are unknown. Forest River initiated a formal investigation on December 20, 2017. A Corporate Quality Inspector visited the manufacturing plant to review the installation of the optional equipment. Since there were not any vehicles being manufactured at the time of the Inspectors visit due to the end of the year shut down, the Plant Manager reviewed the plant's installation practices and observed inconsistencies in the electrical installation.

This information was communicated to Forest River's Office of Corporate Compliance on January 4, 2018. On January 5, 2018, Forest River decided to conduct a recall to address this issue.

Description of Remedy :

Description of Remedy Program : Dealers will inspect the vehicles for the condition. If the condition is present, Forest River will provide all labor and parts free of charge to the dealerships and vehicle owners. A dealership will be required to conduct this remedy.

How Remedy Component Differs from Recalled Component : Vehicles will be inspected and if incorrectly installed, the subject 14 gauge wire will be relocated to another 14 gauge wire terminated on the neutral bus bar.

Identify How/When Recall Condition was Corrected in Production : The last vehicle manufactured with this option were built on October 30, 2017. The condition was corrected in production after a process review during the week of December 20, 2017.

Recall Schedule :

Description of Recall Schedule : Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
