Description of the Defect : According to the recall notice provided by Ford; "It may be possible for water to collect and splash in the driver's side footwell area of the vehicle where the Trailer Module that controls trailer lighting is located. Water intrusion may cause wiring corrosion and damage to the Trailer Module".

Description of the Safety Risk : According to the recall notice provided by Ford; "Trailer Module water intrusion may result in rapid flashing of the turn signals, loss of instrument cluster display, loss of heater and air conditioning controls, and loss of multimedia (radio, display screen, SYNC). Wiring corrosion from prolonged water intrusion could also result in an electrical short, which could cause an uncommanded seatbelt pretensioner deployment, a burning smell, and/or increased risk of fire, including when the vehicle is parked and the ignition is off."
