**Description of the Defect :** The refrigerator in the slideroom does not have an air cycling fan installed to promote cooling of the refrigerator parts.

**FMVSS 1 :** NR

**FMVSS 2 :** NR

**Description of the Safety Risk :** The refrigerator may overheat, which could cause the cooling tubes to fail. If the tubing were to become punctured, this increases the potential for a fire risk.

**Description of the Cause :** An incorrectly specified refrigerator was installed into the vehicle.

## Chronology :

During a review of the Surveyor plant's manufacturing processes, on May 2, 2018, the plant discovered a possible issue involving the incorrect refrigerator without a cooling fan being installed on specific models. Forest River's Office of Corporate Compliance ("OCC") initiated an investigation into the issue which revealed that this vehicle model had a refrigerator installed without a cooling fan.

Forest River reviewed internal data and found no warranty claims or customer complaints potentially related to this issue.

On May 4, 2018, Forest River's Corporate Committee decided to conduct a recall.

## Description of Remedy :

Description of Remedy Program : Forest River will provide the fan assembly, free of charge, and pay for the installation of the fan assembly. A dealership must install the fan assembly.
