Description of the Defect : The fasteners used to mount the awning arms to the sidewall of the recreational vehicles are of insufficient length, and/or quantity, this could potentially allow the awning arm to come loose from the sidewall.

On 9/10/2018 Forest River's Office of Corporate Compliance received a report from our manufacturing plant stating they had received notification of a possible or upcoming Technical Service Bulletin from Carefree of Colorado.

On 9/10/2018 Forest River's Office of Corporate Compliance started an investigation.

On 10/04/2018 Forest River's Office of Corporate Compliance initiated a call to Carefree of Colorado regarding a copy of the bulletin and any data that would support failures occurring in the field.

On 10/12/2018 Forest River's Corporate Recall Committee was notified and supplied a copy of the bulletin, the committee asked for additional information to determine level of safety risk.

On 10/17/2018 Forest River's Office of Corporate Compliance, initiated a conference call with Carefree of Colorado to gather additional information.

On 10/19/2018 Forest River's Corporate Recall Committee voted to elevate the bulletin to recall

Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
