Chronology:

On November 26, 2018, while inspecting a 2019 Model Year XTS vehicle for an unrelated repair, an operator at GM's Oshawa manufacturing plant discovered that a front seat buckle on the vehicle could pull loose from its cable mounting strap and decorative sleeve due to the absence of a securing rivet. On November 28, a GM Assembly Quality Engineering Manager created a Speak Up for Safety report to document the discovery and condition.

On November 29, an inspection of suspect parts and VINs at seat supplier Lear and at GM's Oshawa plant began, and on November 30, buckle supplier Wooshin Safety Systems conducted an inspection of its unshipped parts.

On December 4, GM opened a product investigation for this issue. The investigation determined that Wooshin's automated system used to verify the presence of a formed rivet in the buckle was inadvertently bypassed when a test engineer failed to return the system to "RUN" mode after testing on August 31, 2018. The first production day following testing at Wooshin was September 3. The rivet verification system was not placed back into "RUN" mode at the suppler until December 2, 2018, although Wooshin did implement visual verification of the rivet's presence beginning November 27, 2018, as part of its containment effort. After identifying production dates and accounting for finished parts and work in process inventory at GM's suppliers and in GM's assembly plant, the investigation identified 175 vehicles in the field that were built with suspect buckle assemblies.

The investigation was reviewed in GM's Global Open Investigation Review (GOIR) on December 12, 2018. On December 13, GM's Safety Field Action Decision Authority (SFADA) decided to conduct a safety recall for the remaining 175 vehicles.
