Description of the Defect : The latch that holds the front, rear and side bunk bed latch closed during transit may have insufficient fasteners. Potentially allowing the bunk bed to deploy while in transit.

FMVSS 1 : NR

FMVSS 2 : NR

Description of the Safety Risk : If the bunk bed latch fasteners fail allowing the bunk to deploy during transit, it may lead to reduced handling of the vehicle, increasing the risk of a crash.

Description of the Cause : The manufacturing line used an insufficient fastener to secure the bunk latch to the body of the vehicle.
