Pursuant to 49 CFR 583.17, American Automobile Labeling Act, General Motors LLC is providing domestic content information specified in Part 583, Section 17 for the 2019 model year vehicle lines as listed in the enclosed attachment. The information specified in Part 583, Section 17 is provided for passenger cars and light trucks less than 8500 pounds gross vehicle weight rating.

The 2019 model year has vehicle launches staggered throughout the 2018 calendar year and the beginning of the 2019 calendar year. This first letter covers the first of 2019 model year programs, the Chevrolet Corvette. There are additional vehicle models that will start production later in the year and supplements to this letter will be submitted accordingly as the models are introduced.
